PUBLIC NOTICE FOR INVITING OBJECTIONS ON ELECTRICITY
DEPARTMENT, PUDUCHERRY TARIFF PETITION
AND
SCHEDULE OF PUBLIC HEARING

Electricity Department, Puducherry (EDP) has filed a petition for approval of Aggregate Revenue Requirement (ARR) and determination of Tariff for Retail sale of Electricity for the FY 2009-10 under section 62 of the Electricity Act, 2003 before the Joint Electricity Regulatory Commission for Goa and UTs.

EDP had published a public notice on 12/10/2009 in leading Newspaper of the Union Territory indicating therein the ARR and salient features of the proposed tariff for the FY 2009-10 inviting suggestions / objections from the public up to 31/10/2009. The above said public notice & Tariff petition of Electricity Department of Puducherry is available on www.electricity.puducherry.gov.in. The Public hearing by the commission was scheduled on 11.11.09 in Yanam & 13.11.2009 in Puducherry respectively. However, the same had to be deferred in compliance with the stay orders dated 11.11.09 & 01.12.09 passed by of the Hon'ble High court of Madras at Chennai in Writ petition nos.23070, 23071 & 23074, 23079. Now the stay orders has been vacated by Division Bench of the Hon'ble High Court of Madras at Chennai on 14.12.2009.

In compliance and accord with the aforesaid order of the Division Bench of the Hon'ble High Court of Madras at Chennai, the JERC has already put on its website www.jercuts.gov.in the draft regulations called Joint Electricity

Regulatory Commission for State of Goa and Union Territories (Terms and Conditions for Determination of Tariff) Regulations, 2009 under section-61 read with Section 181 of the Electricity Act, 2003 on 18.12.2009. JERC has also issued the required public notice and same has appeared in Newspapers on 19.12.09 for inviting the objections/suggestions on draft regulation on terms and conditions for determination of tariff. The said public notice is also available on the Commission's website www.jercuts.gov.in.

This Notice is hereby being published for inviting the objections / suggestions/additional objections on tariff petition of EDP keeping in view the draft regulation of the commission on terms and conditions of determination of tariff.

Objections / suggestions if any, on the EDP Tariff petition, together with supporting material may be filed with the Secretary, Joint Electricity Regulatory Commission (JERC) for Goa & UTs, Second floor, HSIIDC Office complex, Vanjiya Nikunj, Complex, Udyog Vihar, Phase-V, Gurgaon – 122016 (Haryana) in five copies in person or through registered post so as to reach him on or before **28/12/2009**.

The objections / suggestions as above should be filed in five copies and carry full name and postal address of the person sending the objections and should be supported by an affidavit duly attested. If the objection is filed on behalf of any organization or any class of consumers, it should also be mentioned. It may also be specifically mentioned if the person putting in objections / comments also wants to be heard in person.

Accordingly the public hearing has been scheduled in Yanam & Puducherry to hear and consider the objections/suggestions on EDP tariff petition.
