The Commission invites applications from interested person for appointment to the post of the Ombudsman in accordance with Joint Electricity Regulatory Commission (Appointment and Functioning of Ombudsman) Regulations, 2009 for the State of Goa and Union Territories of Andaman & Nicobar Islands, Chandigarh, Dadra & Nagar Haveli, Daman & Diu, Lakshadweep and Puducherry.

The commission also invites applications from interested persons familiar with consumer affairs for nomination as a Member on each of the 3 – Member Forums for Redressal of Consumer Grievances, to be set up by each of the electricity Distribution Licensees (presently the respective Departments of Power) in the Union Territories of Andaman & Nicobar Islands, Dadra & Nagar Haveli, Daman & Diu and Lakshadweep.

Invitation of Application for appointment of Ombudsman for JERC

The Commission as per JERC (Appointment & Functioning of Ombudsman) Regulations, 2009, has to appoint an Ombudsman for Redressal of Grievances of Consumers in the State of Goa and the Union Territories of Andaman & Nicobar Islands, Chandigarh, Dadra & Nagar Haveli, Daman & Diu, Lakshadweep and Puducherry.

The person applying shall be a person of ability and standing and shall either be former judge not below the rank of District Judge, or a retired Civil servant not below the rank of Additional Secretary to the Government of India or Principal Secretary to a State Government or equivalent, or a person who has worked for least three (3) years as a member of the regulatory body or Chief Executive Officer/ functional Director of an electricity or electricity related utility.

The Ombudsman so appointed shall be entitled to monthly lump-sum allowance of Rs 42000/- per month and actual travel expenses limited to Economy class airfare and local travel not exceeding Rs 1000 per day.

The application giving the following data, and accompanied by attested copies of supporting document/ testimonials, and two references from responsible persons of the area, must reach the undersigned by 18.11.2009.

(ix) Whether Member of any NGO (with brief description on NGO) (x) Preference of location / UTs for nomination.
