1. The Petitioner, Electricity Department of Andaman & Nicobar Administration has been allowed to function as Distribution Utility for UT of Andaman & Nicobar. For supply to its customers, the petitioner sources from its own generating stations and a small quantum is purchased from other sources.

2. Pursuant to the enactment of the Electricity Act, 2003, EDA&N is required to submit petition for approval of Power Purchase Agreements as per procedures outlined in section 62 & 86(1)(b), of EA 2003, and the governing regulations thereof.
3. EDA&N prays to the Hon'ble Commission to admit the attached petition and would like to submit that:
 - 1.0 Presently generation of electricity in the Andaman & Nicobar Island is done primarily through diesel generating units. The cost of generation from such diesel based generating units is very high. Further these generating stations are not very clean and may affect the ecology of the A&N Islands.
 - 2.0 In order to make a gradual shift to the green power, the Electricity Department Port Blair has signed an agreement with M/s Darashaw & Company Pvt. Ltd., Mumbai on 30.12.2009 for providing consultancy services for establishment, operation, maintenance and monitoring of 2 MW Biomass based power plant at South Andaman.
 - 3.0 The RFQ & RFP prepared by the Consultant and the RFQ was floated through A&N Administration's website against which three developers submitted their application. All three applications received were found qualified both in technical and financial criteria. Based on this the Request For Proposal was forwarded to all the three bidders. Finally two developers submitted their proposals and on comparing the rates it is found that M/s Suryachakra Green Fuels Pvt. Ltd. Hyderabad has quoted the lowest tariff rate of ₹ 9.81. The copy evaluation report attached as Annexure- I.

- 4.0 The Letter of Award (LOA) (copy attached as Annexure-II) was forwarded to M/s Suryachakra Green Fuels Pvt. Ltd. Hyderabad on dtd. 14.03.2012 and as per the terms of LOA, a draft Detail Project Report (DPR) was submitted by M/s Suryachakra Green Fuels Pvt. Ltd. Hyderabad. The copy of DPR is attached as Annexure- III.
- 5.0 M/s Suryachakra Green Fuels Pvt. Ltd. Hyderabad projected in Chapter - XII, of the DPR reflected the cost of the project as ₹ 14.9511 Crores and the span for Power Purchase Agreement for this Biomass based power plant is 20 years. The firm M/s Suryachakra Green Fuels Pvt. Ltd. Hyderabad have also submitted the performance security of ₹ 50.00 lakhs and unless the PPA is signed, no other works like development of the land, procurement of plant and equipments and construction of building can be started.
- 6.0 The work on this project need to be immediately started and for which the PPA need to be signed. In view of this it is requested that the Hon'ble commission shall give necessary In-Principle approval for purchase of power from this proposed 2 MW Biomass based power plant as per the terms and condition the tariff proposed through open competitive bidding. On getting the in principle approval from Hon'ble Commission, PPA shall be entered with M/s Suryachakra Green Fuels Pvt. Ltd. Hyderabad for purchase of entire power from this power plant. The draft PPA is enclosed as Annexure - IV.

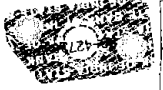
